I, the undersigned, for myself, and on behalf of my personal representatives, heirs, and next of kin, in consideration of any event sponsored, promoted or directed by **BARNYARD MUDBOGGERS, LLC**, and for my being allowed to play and participate in any way **HEREBY RELEASES** any affiliated owners, shareholders, directors, promoters, sponsors, employees, lessor or other landowners and agents of all liability to the undersigned, whether caused by negligent act, or omission of Releasees or otherwise while the undersigned is for any purpose participating in such an event. It is fully understood by each of the undersigned that there is inherent risk associated with this event, including damage to vehicles, and I, the undersigned, fully assume the risks involved.

IN ADDITION, the undersigned **AGREES TO INDEMNIFY, AND HOLD HARMLESS** the Releasees from any loss, liability damage, or cost they incur due to such participation by the undersigned, whether caused by Releasees negligence or otherwise and **AGREES TO ASSUME FULL RESPONSIBILITY AND RISK** for any bodily injury, death, or property damage from the Releasees negligence or otherwise while the undersigned is participating in this event.
